Be It Remembered that the Greene County Council met in Regular Session on Thursday, October 28, 2019 at 4:00 p.m. in the Commissioners' Room on the third floor of the Courthouse.

The meeting was called to order by Jerry Frye.

Re: Minutes

The minutes of the regular meeting held on October 3, 2019, was approved with one amendment, with reading waived, on a motion made by Brent Murray. Ron Lehman seconded the motion. Motion passed 6-0.

Re: I.T. Department – Part-Time Wage Request

Ron Lehman made a motion to approve the request from I.T. Director Chuck Long to pay a part-time employee \$15.00 per hour. This is needed because of the knowledge one would have to possess upon being hired. Jonas Uland seconded the motion. Motion passed 6-0.

Re: Coroner - Additional Appropriation Approval

Brent Murray made a motion to approve the additional appropriation in the amount of \$11,000.00 within the General Fund for Pathologists as requested by County Coroner Joe Graves to pay for the number of autopsies performed this year. Jonas Uland seconded the motion. Motion passed 6-0. 1000-007-03-0021 General Fund – Pathologists \$11,000.00

Re: Highway Department Superintendent - Additional Appropriation Approval

Brent Murray made a motion to approve 2 additional appropriations totaling \$393,245.18 within the Highway Fund for the Lone Tree Road Project, the funds of which were paid to INDOT as part of the county's 20% match toward the Project and are being reimbursed back to the County Highway Department. This was requested by Highway Department Superintendent Roger Hamilton in order to use the reimbursement funds again. Ron Lehman seconded the motion. Motion passed 6-0.

Brent Murray made a made a motion to approve the budget transfer as requested by Highway Department Superintendent Roger Hamilton in the amount of \$95,286.48 within the Highway Fund for use with the Lone Tree Project. Ron Lehman seconded the motion. Motion passed 6-0.

Re: Health Officer – Waiving of Employee 90-day Probationary Period

Ron Lehman made a motion to allow Health Officer Dr. Peter Powers to waive the 90-day probationary period for 4 of the Health Department's new employees, including Registrar, Environmental Health Specialist, Nurse, and Clerical Assistant, so that these employees would not earn 10% less than the normal pay rate for that position. Gregg Roudebush seconded the motion. Motion passed 6-0. It is noted that the Environmental Health Specialist will receive pay retroactive to her hire-in date. The Council also directed County Attorney Marvin Abshire to take the hire-in rate wording out of the 2020 Salary Ordinance, which would alleviate the need to go to the Council in the future.

Re: Chief Probation Officer – Additional Appropriation Approval

Gregg Roudebush made a motion to advertise for an additional appropriation in the amount of \$8,000.00 within the General Fund as requested by Chief Probation Officer Mike Pate to help pay for

salaries that can no longer be paid from other funds which are currently in the red. Ron Lehman seconded the motion. Motion passed 6-0.

addition of language regarding the acceptance of candidates with a Bachelor of Science in Nursing, a Registered Nurse, or Licensed Practical Nurse, in particular those who have relevant work experience along with those seeking to further their education. Kelly Zimmerly seconded the motion. Motion passed 7-0. Terms of this Job Description are incorporated by reference.
