IDPC qualifications require a quarter time person to meet the "adequately" staffed requirement. This averages out to only needing someone on average for 8.75 hours per week. Between use of interns and a contract investigator, the Public Defender's office will still meet the goal of remaining adequately staffed. • \$168,064.15 -County Corrections -Three 2025 Ford Police Utility vehicles from Bloomington Ford, Safety Systems, Shad's Signs lettering, transport cages for two current fleet vehicles, and work to Sheriff's truck.

Jerry Frye moved, and Ron Lehman seconded, to approve advertisement for additional appropriation in the amount of \$168,064.15. Motion passed 6-0.

Re: Drug & Alcohol – Nicole Noel – presentation

Nicole Noel provided a presentation of the various programs supported by the Greene County Drug & Alcohol office. Nicole provided statistical information that included:

- a. Annual Report for 2023 Drug Court Services Program.
- b. Local Coordinating Council distribution report conducts 6 meetings per year.
- c. Pretrial Program 8 referrals, 4 completed, 3 active, and 1 terminated.
- d. Mental Health Court This intense program is proving more difficult to get moving. Two have been accepted, one is pending and three have been rejected.
- e. Education classes 28 male participants 39 female participants.
- f. Works with Strengthening Families program.
- g. Coping and Support Training (CAST) -prevention program for middle and high school aged youth.

Re: GCAS Director Doug Hall

- Implementation of Transfer Truck Program GCAS Director Doug Hall informed the Council that the Emergency Medical Service Board approved a transfer truck pilot program during peak times at the Greene County General Hospital. Currently, there is money in the GCAS budget to pay for the program. Doug Hall also added that he will have a full staff for the eclipse.
- Approval for Station Officer enhancement of duties and compensation GCAS Director Doug Hall informed the Council that the Emergency Medical Service Board has approved, pending Council approval, assigning three station officers to handle daily issues. Doug proposed that the station officers receive a \$.50 per hour or \$1,700.00 per year, per person increase, for a total of \$5,100.00 for all three officers to be paid from GCAS's longevity fund. Marvin noted this change would involve reference to the enhancement in each base description (EMT, paramedic) that addresses selection for the enhanced role as an additional duty/set of duties over and above basic duties. Ron Lehman moved, and Bryan Woodall seconded, to approve transfer of \$5,100.00 from Longevity to a new line item for Station Officer. Motion passed 5-1. Karen Abrams voted nay. Marvin and Doug are to work further on position description revision and present those descriptions for consideration at the next council meeting.
