# Re: Easy Water Systems

Dean T. Freije from Easy Water Systems gave the Commissioners a proposal on the salt removal treatment services for both the courthouse and Jail as was discussed at the December 3, 2013 Commissioners' Meeting. Mr. Freije gave an estimate of \$5,910.00 for the courthouse and \$7,960.00 for the Jail. Mr. Freije said that his company could install the systems within one to two weeks of notification of approval of the proposal. Ed Michael made a motion to table the approval until the February 4, 2014 Commissioners' Meeting in order to give the Commissioners more time to look at the proposal. Nathan Abrams seconded the motion.

## Re: County Auditor – 2013 Annual Financial Report

The Commissioners reported at this their second meeting in January a list of all fund beginning balances, receipts, disbursements, and ending balances of the previous year. The Commissioners directed the county auditor to post said balances in the courthouse as well as the local newspapers as soon as possible.

#### Re: INDOT and The Indiana Railroad – Guard Rail Installation

Rick Graves made a motion to allow INDOT in conjunction with The Indiana Railroad to install a guard rail system near their property on CR350N in order to protect the property from vehicles that use it as a turn-around out of the Redbird Recreational Area. The Commissioners directed County Attorney Marilyn Hartman to work out the details of such an agreement with the Department of Natural Resources.
