Re: Minutes

The minutes of the regular meeting held on May 21, 2013 were approved on a motion made by Ed Michael. Nathan Abrams seconded the motion. Motion passed.

Re: Claims

Ed Michael made a motion to approve all claims submitted for payment on June 4, 2013. Nathan Abrams seconded the motion. Motion passed.

Re: Four Rivers Resource Services - Budget Discussion

Four Rivers Resource Services Representative Steve Sacksteder presented the Commissioners with a booklet that shows the many services that his organization provides to those with certain disabilities to help them be as independent as possible. He expressed his appreciation for the Commissioners ongoing support, a request in the amount of \$60,437.00 for 2014. Ride Solutions Representative Becky Guthrie also gave a presentation to the Commissioners of the growing use of Ride Solutions services to the public. She asked for a 2014 budget amount of \$5000.00, which is the same as the 2013 budget amount. The Commissioners thanked both for their time and information.

Re: Courthouse Lawn Maintenance

Re: Road Permit Agreement – Crider & Crider, Inc.

Ed Michael made a motion to approve the Road Permit Agreement between the Board of Commissioners of Greene County and Crider & Crider, Inc. regarding haul roads that the contractor will use in construction of a part of I-69. Nathan Abrams seconded the motion. Motion passed. The contractor has a surety bond to help with any damage to the haul roads during construction. Terms of this Agreement are incorporated by reference.

Re: Bridge #260 Appraisal Report

Rick Graves noted that this approval was dependent upon the careful reviewing of the document by Nathan Abrams and County Attorney Marilyn Hartman.
